DEFINITIONS

- Treatment Technique (TT) A required process intended to reduce the level of a contaminant in drinking water.

GENERAL INFORMATION

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water posed a health risk. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. COLIFORM ASSESSMENT

During the past year we were required to conduct1 Level 1 assessment to determine the cause of bacteria in our distribution system. Corrective actions have been or will be taken to address these issues. If a health concern is present, you will be notified.

A Level 1 Assessment is a study of the water system to identify potential problems and determine (if possible) why total coliform bacteria have been found in our water system.

SOURCE WATER ASSESSMENT INFORMATION

This water supply obtains its water from the dolomite of the Silurian aquifer. The Silurian aquifer was determined to be slightly susceptible to contamination because the characteristics of the aquifer and overlying materials provide moderate protection from contaminants at the land surface. The Silurian wells will be slightly susceptible to surface contaminants such as leaking underground storage tanks, contaminant spills, and excess fertilizer application.
